

Jumpin' Beenz Amusements & Party Hire Rental Agreement

1. **EQUIPMENT, RENT & TERMS OF RENTAL AGREEMENT:** The undersigned, as Lessee, hires from Jumpin' Beenz Amusements & Party Hire as Lessor, one Jumpin' Beenz Unit, and identification name as:
2. **DELIVERY:** To the street address specified above by Lessee (customer). Lessee grants lessor the right to enter the property at the said address (delivery address) for the delivery & subsequent pick up of the Jumpin' Beenz unit at the specified time.
3. **TRANSPORTATION EXPENSE:** Except as provided herein, all charges in delivering & subsequent pick up of the Jumpin' Beenz unit with respect to the Delivery Address are included in the rental fee noted above. In the event that the Jumpin' Beenz unit is not returned at the appointed time by Lessee to Lessor then a \$50 transportation fee shall be automatically imposed.
4. **GENERAL RULES TO FOLLOW DURING USE OF THE JUMPIN BEENZ UNIT:**
 - (a) Only compatible agreed age groups & size shall play on the Jumpin' Beenz unit at the same time
 - (b) All riders **MUST REMOVE SHOES** before playing in the Jumpin' Beenz unit.
 - (c) To avoid neck & back injuries, **FLIPS ARE NOT ALLOWED.**
 - (d) **CHILDRENS SAFTY DEPENDS ON YOU. YOUR PERSONAL SUPERVISION IS ABSOLUTELY REQUIRED. AS THE LESSEE OF THE JUMPIN BEENZ UNIT, THE SAFTY AF ALL RIDERS IS YOUR RESPONSIBILITY.**
 - (e) Absolutely no "SILLY STRING", GUM CANDY, FOOD or other Sticky substances are allowed in the Jumpin' Beenz unit. If upon pick up, such cleaning is required then a \$50 cleaning fee shall be automatically imposed.
 - (f) **DO NOT MOVE THE JUMPIN BEENZ UNIT** from the place where it was installed. If the Jumpin' Beenz unit moves, pull the corner back to its original location of installation. **CAUTION: KEEP AWAY FROM SWIMMING POOLS.**
5. **SPECIAL INSTRUCTIONS:** The Jumpin' Beenz unit's equipment is reliable. Should the Jumpin' Beenz unit begin to deflate:
 - (1) The motor may have stopped, in which case, check the cord connection at the outlet near the motor, & remember to keep only the 20m extension cord or blockage, & check both tubes at the back of the Jumpin' Beenz unit for snugness, re-tie if necessary.
 - (2) If you cannot correct the problem call 0490 881 364.
6. **SAFE OPERATION ACKNOWLEDGMENT:** Lessee acknowledges that he/she has been instructed about and fully understands the safe operation of the Jumpin' Beenz unit that is the subject of this Rental Agreement. Lessee agrees to observe all the safety precautions. Lessee also represents & warrants the safe return of the unit & hereby agrees to pay the full price on the hired items, if it is not returned.
7. **MAITENANCE:** Lessee agrees to keep the Jumpin' Beenz unit in the same condition as when received, ordinary wear expected.
8. **WARRANTY:** Lessor warrants that the Jumpin' Beenz unit leased under this rental agreement will be in good working order on the effective date of the rental agreement. The Jumpin' Beenz unit is supplied and maintained subject to this warranty. Lessor's obligation under this Rental Agreement is limited to repair or replacement of the Jumpin' Beenz unit when the Lessor determines that it does not confirm to this warranty. This warranty is in lieu of any & all other warranties expressed or implied, & of any and all obligations & of all liabilities on the part of the Lessor for damages, including but not limited to, consequential damages, arising out of or in connection with the use or performance of the Jumpin' Beenz unit.
9. **TITLE TO:** Lessee agrees to keep the Jumpin' Beenz unit in his/her custody not to sublease, rent, sell, remove from the Delivery address, or otherwise transfer such Jumpin' Beenz unit. The Jumpin' Beenz unit will remain the property of the Lessor & may be removed by Lessor at any time after the termination of this Rental Agreement.
10. **RELEASE OF LIABILITY:** The Lessee shall be in charge of the Jumpin' Beenz unit's operation, & is fully responsible for its operation as well as return of Jumpin' Beenz unit in good working order. Lessor and its officers, employees & agents is/are not responsible for injury occurring to the Lessee or any other persons using the Jumpin' Beenz unit, & the Lessee further agrees to hold its officers, employees, & agents free & harmless against any injuries & claims. The Lessee shall indemnify the Lessor & its officers, employees & agents from/against any costs incurred due to claims from anyone & for attorney's fees & related costs involving the use of & return of the Jumpin' Beenz unit, should legal action become necessary?
11. **ENTIRE AGREEMENT:** The Rental Agreement constitutes the full agreement between Lessor & Lessee. Time is of the essence in this Rental Agreement. The receipt of the Jumpin' Beenz unit that is the subject of this Rental Agreement is in good working order & repair & this is so acknowledged by Lessee.
12. **RAIN POLICY:** During periods of severe weather conditions (i.e. rain, high winds, etc), we reserve the right to cancel your reservations. If conditions are not too severe we will give you the option of keeping it or not. If you decide to keep the unit for the term of this Rental Agreement, there will be no refunds!
